**PROTECTED AREAS (*ENVIRONMENTAL ASSESSMENT ACT*) REGULATION**

**B.C. Reg. 248/2019**

**Definition**

**1** In this regulation, “**Act**” means the *Environmental Assessment Act*.

**Prescribed protected areas**

**2** The areas set out in Column 2 of the following table, established by the enactments set out opposite in Column 1, are prescribed as protected areas for the purposes of section 16 (2) (c) (ii) of the Act:

Item	Column 1 Enactment	Column 2 Protected Area
1	<i>Creston Valley Wildlife Act</i>	Creston Valley wildlife management area
2	<i>Ecological Reserve Act</i>	Ecological reserves
3	<i>Environment and Land Use Act</i>	Protected areas
4	<i>Heritage Conservation Act</i>	Provincial heritage sites
5	<i>Park Act</i>	Class A parks
6	<i>Park Act</i>	Class B parks
7	<i>Park Act</i>	Class C parks
8	<i>Park Act</i>	Recreation areas
9	<i>Protected Areas of British Columbia Act</i>	Conservancies
