ORDER OF THE MINISTER OF PUBLIC SAFETY AND  
SOLICITOR GENERAL

*Emergency Program Act*

Ministerial Order No. M152

WHEREAS a declaration of a state of emergency throughout the whole of the Province of British Columbia was declared on March 18, 2020 because of the COVID-19 pandemic;

AND WHEREAS section 10 (1) of the *Emergency Program Act* provides that I may do all acts and implement all procedures that I consider necessary to prevent, respond to or alleviate the effects of any emergency, including causing the evacuation of persons and the removal of personal property from any area of British Columbia that is or may be affected by an emergency, and making arrangements for the adequate care and protection of those persons and personal property;

AND WHEREAS MO 150/2020, the Encampment Health and Safety (COVID-19) Order No. 2 made on May 08, 2020 (the “Evacuation Order”), requires all persons camping in, residing in or occupying Oppenheimer Park (the “Oppenheimer Park Encampment”) to evacuate the area as soon as practicable, but no later than 12:00 p.m. (noon) on May 9, 2020;

AND WHEREAS the Province of British Columbia has implemented a comprehensive plan to provide adequate alternative living arrangements and other health and social supports for persons residing in the Oppenheimer Park Encampment, including the care of their personal property;

AND WHEREAS a number of people living in the Oppenheimer Park Encampment have refused to comply with the Evacuation Order and conditions in the Encampment continue to pose a risk to

- (a) the health, safety and welfare of the persons in the Encampment, and
- (b) the health and safety of first responders, health care workers, and the staff and volunteers of support agencies, who must attend at the Encampment for emergency, injury or health reasons or to otherwise ensure that the complex needs of the vulnerable populations in the Encampment are met;

AND WHEREAS the Vancouver Police Department must, under the *Police Act*, perform the duties and functions respecting the preservation of peace, the prevention of crime and offences against the law and the administration of justice assigned to it or generally to peace officers by the chief constable of the Department, under the standards of the director of police services or under the *Police Act* or any other enactment;

AND WHEREAS municipal police constables have the authority, under the *Offence Act* and the *Criminal Code* (Canada), to detain and arrest individuals for contraventions of the *Emergency Program Act*;

I, Mike Farnworth, Minister of Public Safety and Solicitor General, order that the attached Encampment Health and Safety (COVID-19) Vancouver Enforcement Order is made.

## **ENCAMPMENT HEALTH AND SAFETY (COVID-19) VANCOUVER ENFORCEMENT ORDER**

### **Definition**

- 1** In this order, **“Oppenheimer Park”** means the area known as Oppenheimer Park, as described in the attached Appendix.

### **Application**

- 2** This order applies during the period that starts at 12:00 p.m. (noon) on May 9, 2020 and ends on the date on which the last extension of the declaration of a state of emergency made March 18, 2020 under section 9 (1) of the *Emergency Program Act* expires or is cancelled.

### **Immediate evacuation of Oppenheimer Park**

- 3** All persons camping in, residing in or occupying Oppenheimer Park must immediately evacuate that park.

### **Enforcement by police**

- 4** The Vancouver Police Department is authorized to enforce the provisions of this order and may remove from Oppenheimer Park any person who is not complying with section 3.

### **Police retain operational discretion**

- 5** For certainty, the Vancouver Police Department retains operational discretion as to the manner in which it may carry out enforcement under section 4.

### **Removal of personal property by city**

- 6** The City of Vancouver must provide personnel to assist with the removal of personal property from Oppenheimer Park and may dispose of any unclaimed personal property as the City of Vancouver considers appropriate.

### **Prevention of entry**

- 7** (1) When evacuation of Oppenheimer Park is complete, the City of Vancouver and the Vancouver Park Board must promptly take all reasonable steps to secure Oppenheimer Park in order to prevent persons from entering that park for the purpose of camping in, residing in or occupying that park.  
(2) For the purposes of subsection (1), the City of Vancouver is authorised to enter Oppenheimer Park and construct reasonably necessary structures within that park.
