The Lieutenant-Governor in Council:

The undersigned has the honour to report :-

THAT by Section 2 of the "British Columbia Loan Act 1921" being Chapter 31 of the Statutes of British Columbia for the year 1921 power is given to the Lieutenant-Governor-in-Council to renew and re-issue Treasury Bills issued under the said Act:

THAT a Minute-in-Council was approved by His Honour the Lieutenant-Governor-in-Council on the 7th day of October, 1922, and in pursuance thereof, a Treasury Bill for Twenty-five thousand dollars (\$25,000) with interest at the rate of 5% per annum dated the 2nd day of October, 1922, was issued to The Canadian Bank of Commerce:

THAT such Treasury Bill fell due on the 2nd day of January, 1923, and The Canadian Bank of Commerce has agreed to renew such Treasury Bill:

THAT the Minister of Finance has arranged with The Canadian Bank of Commerce to issue to The Canadian Bank of Commerce in renewal of the said Treasury Bill dated the 2nd day of October 1922, a Treasury Bill in the form following :-

"PROVINCE OF BRITISH COLUMBIA.

Treasury Bill,
Victoria, British Columbia,
2nd Jan., 1923.

\$25,000.

This Treasury Bill entitles The Canadian Bank of Commerce or order to payment of Twenty-five thousand dollars with interest at the rate of 5% per annum at the Banking House of The Canadian Bank of Commerce, Victoria, B.C., out of the Consolidated Revenue Fund of the Province of British Columbia, on the 3rd day of April, 1923."



AND TO RECOMMEND:


THAT the renewal of the said Treasury Bill dated the 2nd day of October, 1922, in the manner and on the terms set out in the recitals hereto be approved:
