



SCHEDULE 1

- 1 *Section 15 of the Employment Standards Regulation, B.C. Reg. 396/95, is amended by striking out “\$15.20” and substituting “\$15.65”.*
- 2 *Section 16 is amended*
 - (a) *in subsection (1) by striking out “\$113.50” and substituting “\$116.68”, and*
 - (b) *in subsection (2) by striking out “\$121.65” and substituting “\$125.06”.*
- 3 *Section 17 is amended*
 - (a) *in paragraph (a) by striking out “\$912.28” and substituting “\$937.82” and by striking out “\$36.56” and substituting “\$37.58”, and*
 - (b) *in paragraph (b) by striking out “\$3 107.42” and substituting “\$3 194.43”.*

- 1 *Section 18 (1) of the Employment Standards Regulation, B.C. Reg 396/95, is amended by repealing paragraphs (a) to (n) and substituting the following:*

(a) apples	\$21.65 a bin (27.1 ft ³ / 0.767 m ³);
(b) apricots	\$24.91 a 1/2 bin (13.7 ft ³ / 0.388 m ³);
(c) beans	\$0.297 a pound / \$0.655 a kg;
(d) blueberries	\$0.502 a pound / \$1.107 a kg;
(e) Brussels sprouts	\$0.207 a pound / \$0.456 a kg;
(f) cherries	\$0.285 a pound / \$0.628 a kg;
(g) grapes	\$23.01 a 1/2 bin (13.7 ft ³ / 0.388 m ³);
(h) mushrooms	\$0.298 a pound / \$0.657 a kg;
(i) peaches	\$23.01 a 1/2 bin (12.6 ft ³ / 0.357 m ³);
(j) pears	\$24.38 a bin (27.1 ft ³ / 0.767 m ³);
(k) peas	\$0.370 a pound / \$0.816 a kg;
(l) prune plums	\$24.38 a 1/2 bin (13.7 ft ³ / 0.388 m ³);
(m) raspberries	\$0.452 a pound / \$0.996 a kg;
(n) strawberries	\$0.436 a pound / \$0.961 a kg.
