

## SCHEDULE 1

***1 Section 2 of the Environmental Assessment Fees Regulation, B.C. Reg. 246/2019, is amended***

***(a) in subsection (1) by striking out “The fees” and substituting “Subject to subsections (2) and (4) to (6), the fees”,***

***(b) by adding the following subsections:***

(4) The fee set out in item 1 of the table is not required to be paid by a proponent of a project that is subject to section 2 (1) of the Environmental Assessment Transition Regulation, B.C. Reg. 249/2019, until after April 1, 2020.

(5) The fee required to be paid set out in item 7 of the table is the amount determined by the chief executive assessment officer, which must be within the range set out in Column 2 for that item.

(6) The chief executive assessment officer may waive the requirement that a proponent pay a fee set out in the table after considering the following:

(a) the size, scope and location of the project;

(b) the current condition of the land base on which the project is located;

(c) the potential for significant adverse environmental, economic, social, cultural or health effects of the project;

(d) in relation to the fee set out in item 11, whether the inspection is required as a result of the actions of a person other than the proponent or holder of an environmental assessment certificate or exemption order. , ***and***

***(c) in the table by repealing items 8 to 10.***

## SCHEDULE 2

***1 The table in section 2 of the Environmental Assessment Fees Regulation, B.C. Reg. 246/2019, is amended by adding the following items:***

Item	Column 1 Service or Duty	Column 2 Fee
10.1	Management plan approval required by an environmental assessment certificate	\$10 000
10.2	Management plan review required by an environmental assessment certificate	\$5 000
10.3	Other post-certificate filings required by an environmental assessment certificate	\$5 000
