BY-LAW NO. 110

A By-law to amend By-law No. 104 of the Regional District of Kootenay Boundary

WHEREAS "Regional District of Kootenay Boundary Zoning and Subdivision By-law No. 104, 1975" has zoned as Rural II, the following lots:

Lots 20 and 21 of District Lot 205, Plan 800, K.D.

Lots 1, 2, 3, 4, 5, 6, 7 and 8 of District Lot 205A, Plan 800, K.D.

Lots 13, 14, 15, 16, 17 and 18 of District Lot 205B, Plan 800, K.D.

Lots 6A, 7A, 8A, 9A, 10A, District Lot 205A, Plan 800, K.D.

Lots 11A, 12A, 13A, 14A, 15A, District Lot 205B, Plan 800, K.D.

Lots 3B, 4B and 6B of S.L. 18, Township 7A, K.D.

Lots 3A, D.L. 205A, Plan 800, K.D.

Lots 27, 28, 33, 34, 35, 36, 42, S.L. 22, Township 7A, Plan 800 K.D.

WHEREAS, District Lot 8383 is zoned Rural III in By-law No. 104, and,

WHEREAS, it is deemed necessary, expedient, and for the public good to rezone the parcels,

NOW THEREFORE, the Board of Directors of the Regional District of Kootenay Boundary, in open and public meeting, enacts as follows:

Lots 27, 28, 33, 34, 35, 36, 42, S.L. 22, Township 7A, Plan 800, K.D.
