A By-law to amend Zoning By-law No. 62

The Regional Board of the Regional District of North Okanagan in open meeting assembled enacts as follows:

1. Rezone Part of Plan B.4488, SE 1/4 Section 34 and NE 1/4 Section 27, Township 18, Range 9, W6M, K.D.Y.D., Electoral Area "F" Old Salmon Arm Road, from Rural-Residential to Residential Two Family.
2. This By-law may be cited as "Rezoning By-law No. 184, 1975, No. 20".
