Pursuant to the Water Act, and upon the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that

WHEREAS Garden Bay Waterworks District is an improvement district under the Water Act and was incorporated by Letters Patent issued on the 29th December, 1960 (Order in Council No. 2953/60); ✓

WHEREAS Scott Bay Waterworks District is an improvement district under the Water Act and was incorporated by Letters Patent issued on the 15th March, 1946 (Order in Council No. 491/46); ✓

WHEREAS the Trustees of the said Districts have petitioned that the Districts be amalgamated by extending the boundaries of Garden Bay Waterworks District to include the lands comprising Scott Bay Waterworks District, by transferring the assets and liabilities of Scott Bay Waterworks District to Garden Bay Waterworks District and thereafter by dissolving Scott Bay Waterworks District;

WHEREAS it is advisable to redescribe the boundaries of Garden Bay Waterworks District to include the lands comprising Scott Bay Waterworks District;

WHEREAS it is advisable that the assets and liabilities of Scott Bay Waterworks District be transferred to Garden Bay Waterworks District and thereafter Scott Bay Waterworks District be dissolved;

WHEREAS it is in the public interest to amalgamate these Districts as recommended;

1. The Letters Patent of Garden Bay Waterworks District be amended by redescribing the boundaries of the District as hereinafter set out:

The tract of land within Group 1, New Westminster Land District and Vancouver Land Registration District, more particularly described as follows:

Lot 1397, except Block 10, Plan 4479 and Reference Plans 810, 884 and 4075;
Lot 2226;
Lot 6 of Lot 2951, Plan 6859 except Plans 10963, 12562, 13512 and Lot 15319;
Lots 1 to 6 inclusive of Lot 2951, Plan 10963;
Lot 9 of Lot 2951, Plan 12562;
Lots 10, 11 and 12 of Lot 2951, Plan 13512;
Lots 13 and 14 of Lot 2951, Plan 15319;
Indian Reserve No. 19 "Suahbin";
Together with all adjacent road allowances.

2. The assets, rights, claims, charges and liabilities for Scott Bay Waterworks District be transferred to Garden Bay Waterworks District.

And further the Registrar of the Vancouver Land Registration District, in order to give effect to such transfer, is hereby authorized:

- (a) to alter his records by substituting as registered owner Garden Bay Waterworks District for Scott Bay Waterworks District in all relevant registers;
 - (b) generally, to delete and alter any endorsement or entry made on any certificate of title or other document deposited in the Vancouver Land Registry Office.
3. Scott Bay Waterworks District be dissolved.
