RE-ZONING BY-LAW NO. 135

A BY-LAW TO AMEND THE ZONING BY-LAW

WHEREAS the regulations relating to Community Planning Area No. 1, made under the provisions of the Local Services Act, have by virtue of the provisions of the Supplementary Letters Patent of the Regional District of Central Okanagan dated October 27, 1969 the effect of being made a By-law of the said Regional District;

NOW THEREFORE the Board of Directors of the Regional District of Central Okanagan, in open meeting enacts as follows:

That the zoning of Lots C and D, RP 10400, D.L. 170, Tp 20, R9Y0 as defined on Zoning Amendment Plan No. 100 be changed from RURAL to RESIDENTIAL.

This By-law may be cited as the Re-zoning By-law No. 135



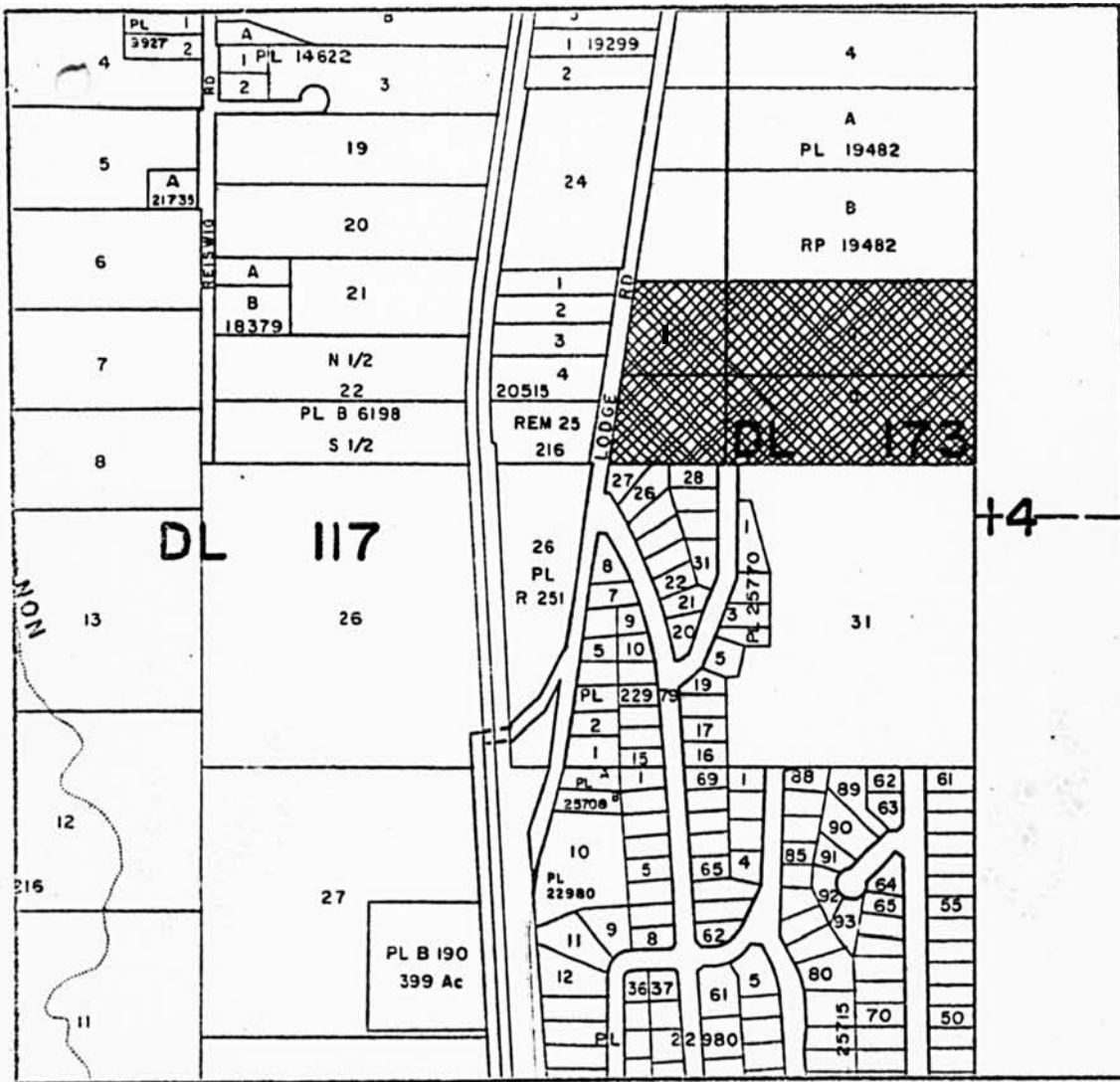
