A By-law to amend Zoning By-law No. 62

The Regional Board of the Regional District of North Okanagan in open meeting assembled enacts as follows:

1. Rezone Part of the NE 1/4 Section 10, Township 40, O.D.Y.D., Lumby-Mabel Lake Road, Electoral Area "D" from Non-Urban (N-U) to Rural-Residential (R-R).
2. This By-law may be cited as "Rezoning By-law No. 195, 1976, No. 3".
