BY-LAW NO. 403.



A BY-LAW to amend the "Burnaby Sidewalk By-law, 1922", being By-law No. 381 of the Corporation.

WHEREAS By-law No. 381 of the Corporation entitled the "Burnaby Sidewalk By-law, 1922" received the assent of the electors of the Municipality on the Thirteenth (13th) day of January, 1923;

AND WHEREAS the works authorized by the said By-law can be finally completed for the sum of Forty-five thousand two hundred and twenty-two dollars and Eighty cents (\$45,222.80);

AND WHEREAS there is a surplus amounting to Twenty-one thousand seven hundred and seventy-seven dollars and Twenty cents (\$21,777.20) arising out of the sale of the debentures authorized by the said By-law;

AND WHEREAS it is desirable and expedient that the said sum of Twenty-one thousand seven hundred and seventy-seven dollars and Twenty cents (\$21,777.20) should be expended in the construction of further new sidewalks in the Municipality;

AND WHEREAS under the provisions of Sub-Section 2 of Section 172 of the Municipal Act any By-law to which the assent of the electors has been obtained may be altered or repealed by the assent of the Lieutenant-Governor-in-Council.

THEREFORE the Municipal Council of the Corporation of the District of Burnaby enacts as follows:-

1. The estimate in said By-law 381 is hereby amended by substituting the figures and word "35,556 miles" for the figures and word "23,952 miles" in the said estimate.

2. The schedule of sidewalks attached to the said By-law No. 381 is amended by adding thereto the schedule attached to this By-law.

3. Any surplus remaining after the construction of the new sidewalks set out in the schedule attached to this By-law shall be applied to the cost of maintenance of sidewalks constructed under By-law No. 381 and this By-law, and for no other purpose.

4. This By-law may be cited as the "BURNABY SIDEWALK BY-LAW, 1922, AMENDMENT BY-LAW, 1923".

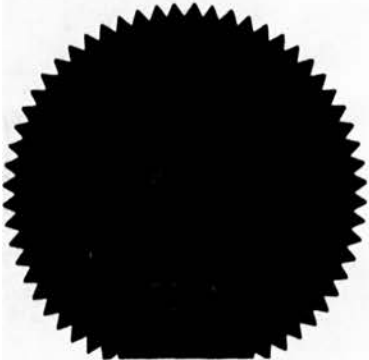
