REGIONAL DISTRICT OF EAST KOOTENAY

BY-LAW NO.

A By-Law to amend By-Law No. 67 cited as "Regional District of East Kootenay Zoning By-Law No. 4, Radium-Dry Gulch, 1972".

WHEREAS an application to amend Section 10 entitled - "USE TABLE C1 - GENERAL COMMERCIAL ZONE", was received by the Regional Board of the Regional District of East Kootenay;

AND WHEREAS the Regional Board deems it desirable to make this Amendment to the By-Law as aforementioned;

NOW THEREFORE the Regional Board of the Regional District of East Kootenay in open meeting assembled, enacts as follows:

1. This By-Law may be cited as "Regional District of East Kootenay Zoning By-Law No. 4, Radium-Dry Gulch, 1972 Amendment By-Law No. 3, 1976".
2. That Section 10(a) be amended by inserting after sub-section (vii), the following:
" (viii) Laundries and dry-cleaners."
3. That Section 10(b) (iii) be amended by inserting after sub-section (e), the following:
" (f) Laundries and dry-cleaners 1 parking space per 2 washing or dry-cleaning machines."
4. That Section 11(a) be amended by inserting after sub-section (x), the following:
" (xi) Laundries and dry-cleaners."
5. That Section 11(b) (v) be amended by inserting after sub-section (d), the following:
" (e) Laundries and dry-cleaners 1 parking space per 2 washing or dry-cleaning machines."
