BYLAW NO. 286 (193-10)

A BYLAW TO AMEND BYLAW NO. 193 THE "ZONING BYLAW FOR ELECTORAL AREAS "E", "I", "M" AND "N" OF THOMPSON-NICOLA REGIONAL DISTRICT, 1975".

WHEREAS an application (No. EI-10) for amendment to zoning Bylaw No. 193 has been made;

AND WHEREAS the changes in uses of land and buildings considered desirable have been approved;

NOW THEREFORE the Regional Board of the Thompson-Nicola Regional District in open meeting assembled enacts as follows:

1. The Zoning Classification on

Part of Parcel "A", Plan "B" 6235, D.L. 377, and Section 7, Township 21, Range 24, W6M, K.D.Y.D., lying on the east side of Trans Canada Highway No. 1, approximately 2 miles south of Cache Creek,

is changed from RL-1 (Rural) Zone to C-4A (Service Commercial) Zone to provide for an existing tire, repair shop and warehouse,

as shown in red on the map attached hereto as Schedule "A".

2. The Zoning Map of Electoral Areas "E", "I", "M" and "N" referred to in Bylaw No. 193 of Thompson-Nicola Regional District is hereby amended to depict the change.

3. This Bylaw may be cited as the "Thompson-Nicola Regional District Zoning Amendment Bylaw No. 286 (193-10), 1976".

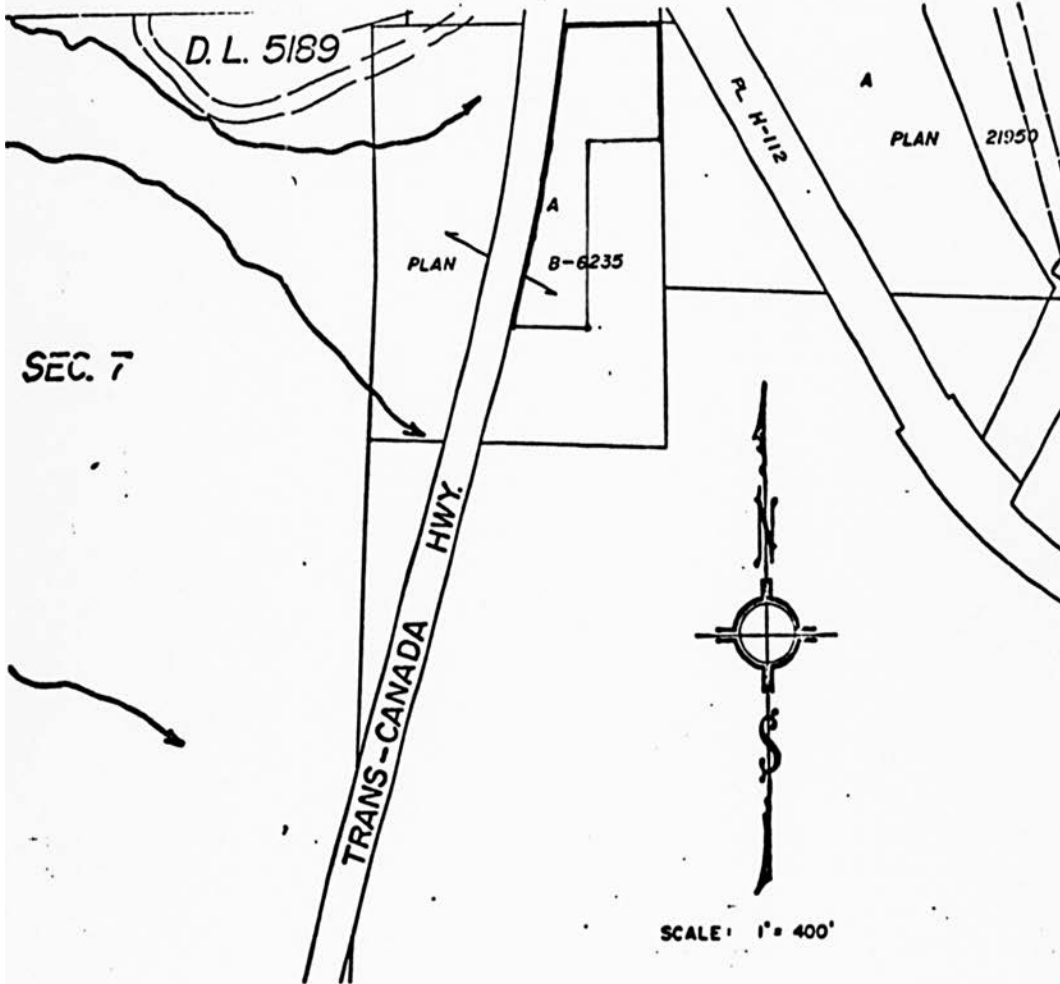
