REGIONAL DISTRICT OF EAST KOOTENAY

BY-LAW NO.

A By-Law to amend By-Law No. 66 cited as "Regional District of East Kootenay Zoning By-Law No. 3, Cranbrook Area, 1972".

WHEREAS applications to re-zone certain lands within the said By-Law were received by the Board of the Regional District of East Kootenay;

AND WHEREAS the Regional Board deems it desirable to make these Amendments to the By-Law as aforementioned;

NOW THEREFORE the Board of the Regional District of East Kootenay in open meeting assembled, enacts as follows:

1. This By-Law may be cited as "Regional District of East Kootenay Zoning By-Law No. 3, Cranbrook Area, 1972 Amendment By-Law No. 1, 1976".
2. The land legally described as Block 5, Plan 033, D.L. 7796, K.D., be re-zoned from A2 - NON-URBAN USE ZONE TO R5 - RURAL RESIDENTIAL ZONE.
