A By-Law to amend By-Law No. 66 cited as
"Regional District of East Kootenay Zoning
By-Law No. 3, Cranbrook Area, 1972".

WHEREAS an application to re-zone certain land within the said
By-Law was received by the Board of the Regional District of
East Kootenay;

AND WHEREAS the Regional Board deems it desirable to make this
Amendment to the By-Law as aforementioned;

NOW THEREFORE the Board of the Regional District of East Kootenay,
in open meeting assembled, enacts as follows:

1. This By-Law may be cited as "Regional District
of East Kootenay Zoning By-Law No. 3, Cranbrook
Area, 1972 Amendment By-Law No. 4, 1976".
2. That part of Block "A", D.L. 5801, Plan 5026,
K.D., as shown outlined in 'red' on the attached
"Schedule A", be re-zoned from A2 - NON-URBAN
USE ZONE to R1 - RESIDENTIAL ONE ZONE.
3. That part of D.L. 5801, as outlined in 'blue' on
the attached "Schedule A", be re-zoned from R1 -
RESIDENTIAL ONE ZONE TO A2 - NON-URBAN USE ZONE.
