BYLAW NO. 288(193-13)

A BYLAW TO AMEND BYLAW NO. 193, THE "ZONING BYLAW FOR ELECTORAL AREAS "E", "I", "M" AND "N" OF THOMPSON-NICOLA REGIONAL DISTRICT, 1975."

WHEREAS an application (No. EI-11) for amendment to Zoning Bylaw No. 193 has been made:

AND WHEREAS the changes in uses of land and buildings considered desirable have been approved;

NOW THEREFORE the Regional Board of the Thompson-Nicola Regional District in open meeting assembled enacts as follows:

1. The Zoning Classification on District Lot 5880, Lillooet District, Lillooet Assessment District, is changed from RL-1(Rural) Zone to CR-1A (Country-Residential) Zone for the purpose of permitting two (2) additional cabins, as shown in red on the map attached hereto as Schedule "A".
2. Zoning Map of Electoral Areas "E", "I", "M" and "N" of Thompson-Nicola Regional District is hereby amended to depict the change.
3. This Bylaw may be cited as the "Thompson-Nicola Regional District Zoning Amendment Bylaw No. 288(193-13), 1976."

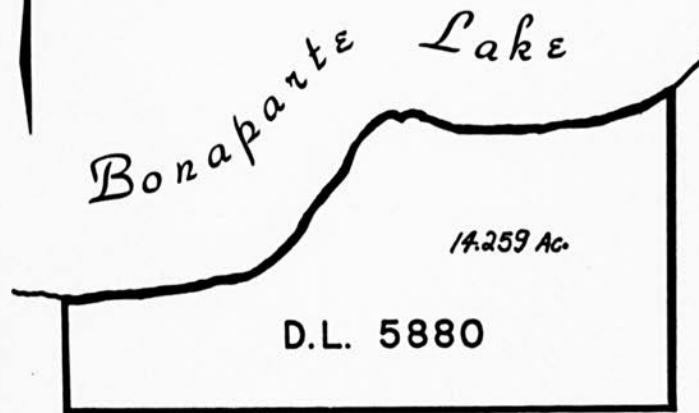
