THOMPSON-NICOLA REGIONAL DISTRICT

BYLAW NO. 298 (147-25)

A BYLAW TO AMEND BYLAW NO. 147 THE ZONING BYLAW FOR ELECTORAL AREAS "A" AND "B" OF THOMPSON-NICOLA REGIONAL DISTRICT, 1973.

WHEREAS an application (No. AB-24) for amendment to zoning Bylaw No. 147 has been made;

AND WHEREAS the changes in uses of land and buildings considered desirable have been approved;

NOW THEREFORE the Regional Board of the Thompson-Nicola Regional District in open meeting assembled enacts as follows:

1. The Zoning Classification on Part of District Lot 4457 Kamloops Division Yale District except those parts thereof:
 - (1.) part described on Certificate of Title 198839^F
 - (2.) included within the boundaries of Plans 16773 and 21050 Kamloops assessment District, is changed from RL-1(Rural) Zone to MH-1A (Mobile Home Park) Zone for the purpose of providing for the remainder of an existing mobile home park, as shown in red on the map attached hereto as Schedule "A".
2. Zoning Map of Electoral Areas "A" and "B" of Thompson-Nicola Regional District is hereby amended to depict the change.
3. This Bylaw may be cited as the "Thompson-Nicola Regional District Zoning Amendment Bylaw No. 298 (147-25), 1976."

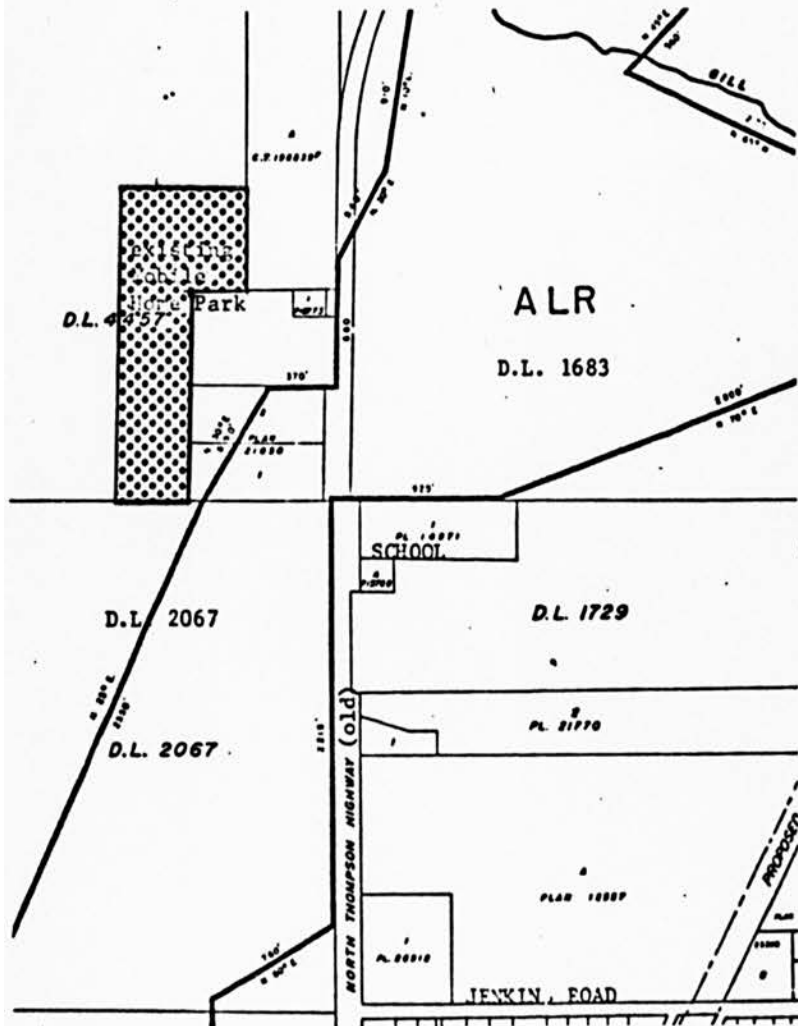
