BY-LAW NO. 4816

A by-law to amend the provisions
of "Surrey Community Plan By-law,
1966, No. 2465".

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey in open meeting assembled, ENACTS AS FOLLOWS:-

1. That portion of the map designated as "Schedule A - Long Range Land Use Plan" of "Surrey Official Community Plan By-law, 1966, No. 2465" as shown outlined red on plan attached hereto and designated as "Amendment Plan to Schedule "A"" is hereby amended from "Urban" to "Industrial". The said area amended is described as follows:-

Lots Twenty-seven (27) to Thirty-one (31) inclusive of the South East Quarter (SE¼) of Section Thirty (30), Township Two (2), Plan 13063, New Westminster District.

2. This by-law may be cited for all purposes as "Surrey Official Community Plan By-law, 1966, No. 2465, Amendment By-law, 1976, No. 4816".

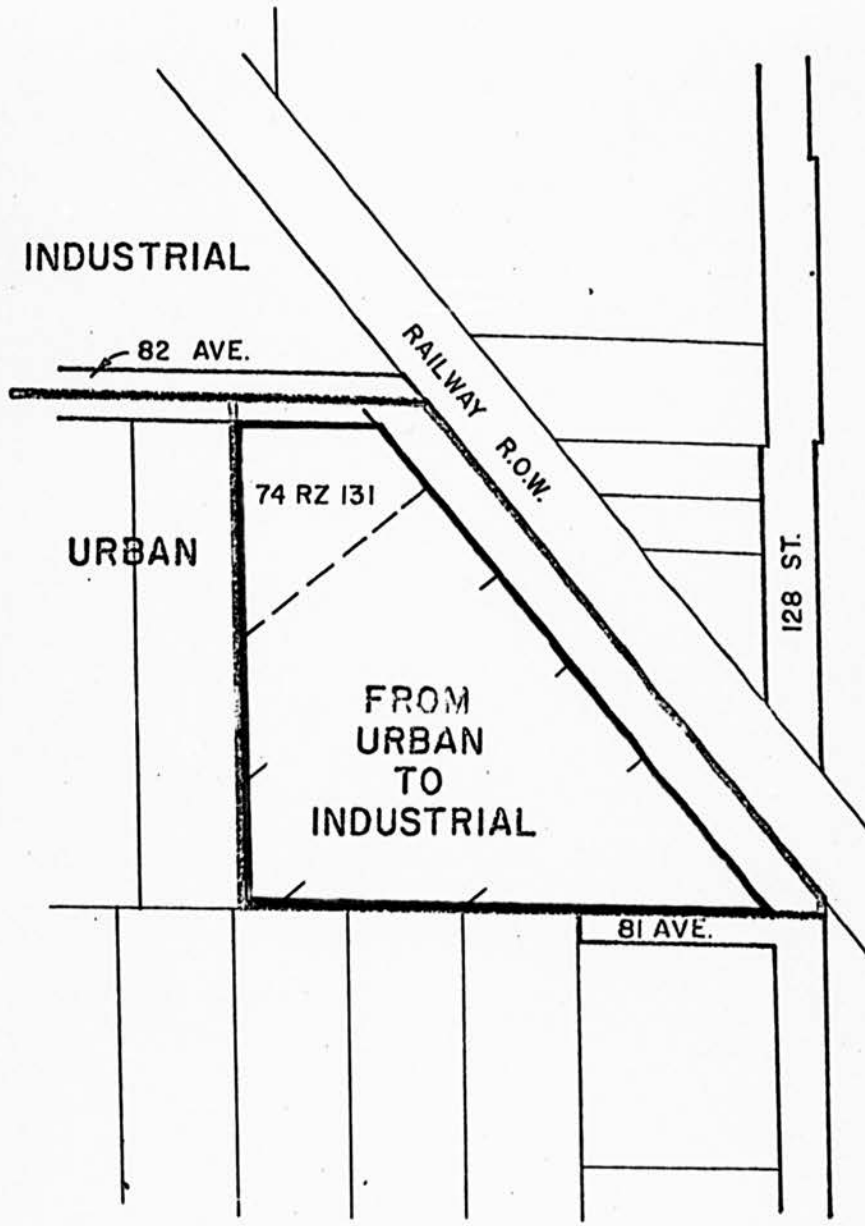
