BY-LAW NO. 252

A BY-LAW TO AMEND BY-LAW NO. 55, BEING THE  
PARKSVILLE-QUALICUM PLANNING AREA ZONING BY-LAW.

WHEREAS the District 69 Communities Plan has been adopted;

AND WHEREAS there is deemed to be a need for certain  
revisions within the Planning Area;

AND WHEREAS the Board of the Regional District of Nanaimo  
deems it expedient to rezone the property;

NOW THEREFORE the Board of the Regional District of  
Nanaimo, in open meeting, assembled, enacts as follows: -

- A. The Regional District of Nanaimo Zoning By-law No. 55, 1972,  
is hereby amended by rezoning:
  - 1. Part of Lot 2, District Lot 122, Nanoose Land District,  
Plan 28760, as shown outlined on Schedule 'A' attached  
to this By-law, from Rural-I to Residential-III zone.
- B. This By-law may be cited as the " Regional District of  
Nanaimo Zoning Amendment By-law No. 252, 1976 ".

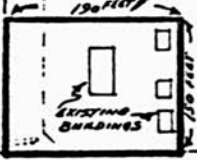
