EXECUTIVE COUNCIL CHAMBERS, VICTORIA SEP. 9 1976

Pursuant to the Highway Act, Section 11 (2) (a) ~~Act~~, and upon the recommendation of the undersigned, the ~~Administrator~~ ^{Administrator}, by and with the advice and consent of the Executive Council, orders that

WHEREAS by Notice dated June 17th., 1976 and published in The British Columbia Gazette of June 24th., 1976, the Minister of Highways and Public Works discontinued and closed all those portions of the Old Nazko Road within the southeast quarter of District Lot 4510, Cariboo District (except Plans 13706, 20837, 21241 and 21287), as shown outlined in green on a plan recorded in the Provincial Department of Highways and Public Works, Victoria, British Columbia, under Road Surveys 4803 (being a copy of Highways District Plan I-17-1).

AND WHEREAS RAYMOND EDWARD NICHOLLS (Stationary Engineer) and LINDA MADELINE NICHOLLS (Nurse), "Joint Tenants", R. R. #3, Quesnel, British Columbia, the registered owners of The South East 1/4 of District Lot 4510, Cariboo District, Except part on Plan 13706, 20837, 21241 and 21287, have paid consideration in the amount of One Hundred and Twenty-five (125.00) Dollars to the Crown for the purchase of the land which comprised this road closure.

AND WHEREAS the Minister of Highways and Public Works agrees that \$125.00 is fair and adequate consideration for this purchase.

THE LAND COMPRISED in the portion of road allowance hereinbefore mentioned be transferred to RAYMOND EDWARD NICHOLLS and LINDA MADELINE NICHOLLS, as Joint Tenants, without further or formal instrument of transfer, but upon compliance with the provisions of the "Land Registry Act" and the possible requirement that a subdivision plan be provided, subject to the conditions of the "Highway Act", and all other powers thereunto enabling, subject to the reservations, limitations, provisos, and conditions expressed in the original grant thereof from the Crown, and to the registered charges, if any, to which the said adjoining lands are subject, with the intent that the land hereby transferred be added to and form part of the said adjoining land, and that the Minister of Highways and Public Works be authorized to execute and deliver such further assurances of the above described lands as may in the premises be required.
