BY-LAW NO. _____

A By-law to amend the "Electoral Area "F" North Campbell River Interim Zoning By-law, 1973" being By-law No. 132 as amended.

The Board of Directors of the Regional District of Comox-Strathcona in open meeting assembled enacts as follows:

PART A

- 1. "Schedule D" shall incorporate the following amendments to the zoning boundaries:
 - a) Lots 1 and 2, District Lot 67, Sayward District, Plan 21021, from R-1 to R-2.
 - b) Part of Lot 1, District Lot 132, Sayward District, Plan 2309, except Plans 1127R and 9386, and that part of Lot 1 shown on 1127R from RM-1 to I-1.

PART B

This By-law may be cited as "Electoral Area "F" North Campbell River Interim Zoning By-law, 1973, Amendment By-law No. 6."





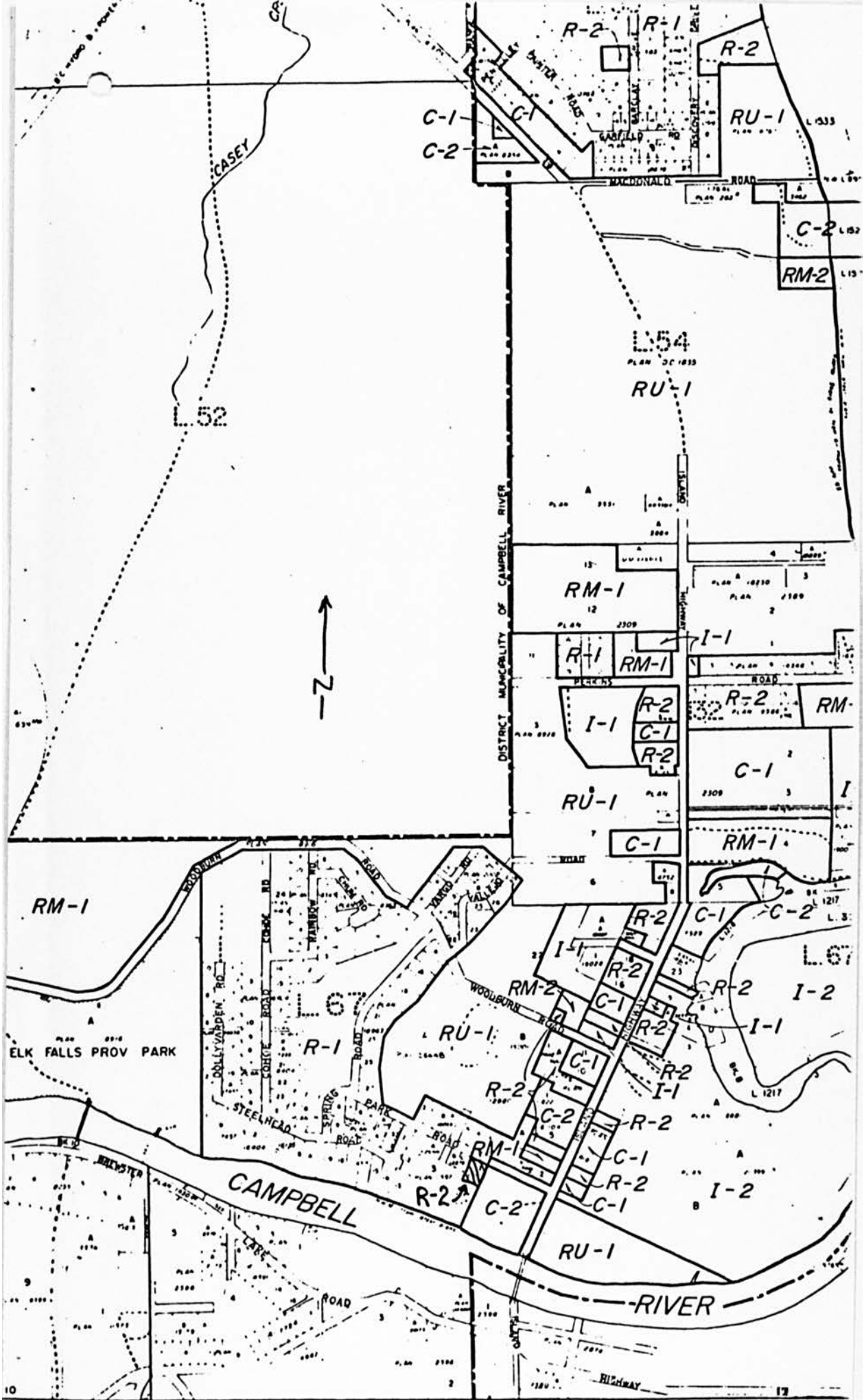
