A BY-LAW TO AMEND THE CITY OF CHILLIWACK AND THE
TOWNSHIP OF CHILLIWACK JOINT CIVIC PROPERTIES AND
RECREATION COMMISSION BY-LAW 1975

1976-56

WHEREAS the Council of The Corporation of the Township of Chilliwack (hereinafter called "the Township") has entered into an Agreement with the Council of The City of Chilliwack (hereinafter called "the City"), as authorized by "The City of Chilliwack and The Township of Chilliwack Joint Civic Properties and Recreation Commission By-law, 1975";

AND WHEREAS the Councils of the Township and the City desire to amend the said Agreement;

AND WHEREAS the approval of the Lieutenant-Governor in Council has been obtained;

NOW THEREFORE the Council of The Corporation of the Township of Chilliwack, assembled in open meeting, enacts as follows:

1. Schedule "A" appended to "The City of Chilliwack and The Township of Chilliwack Joint Civic Properties and Recreation Commission By-law, 1975" is amended as follows:
 - (a) Paragraph 3 is amended by striking out clause (d) and substituting the following:

"(d) A member of the Board of School Trustees of School District No. 33 (Chilliwack) appointed by the Board at its first meeting in each calendar year."
 - (b) Paragraph 16 is deleted.
2. The Mayor and Clerk of the Township are hereby authorized to sign an Agreement in the form set out in Schedule "A", as amended by section 1, and to affix the Seal of the Corporation thereto.
3. This by-law shall take effect only if a parallel by-law is adopted by the Council of The City of Chilliwack, and only after the execution of the Agreement authorized by this amendment by-law.
4. This by-law may be cited for all purposes as "The City of Chilliwack and The Township of Chilliwack Joint Civic Properties and Recreation Commission By-law, 1975, Amendment By-law, 1976".
