THE CORPORATION OF THE CITY OF LANGLEY

LANGLEY JOINT RECREATION COMMISSION BY-LAW 1971

NO. 468

WHEREAS, pursuant to Section 177 of the Municipal Act being Chapter 255 RSBC 1960 and amendments thereto, a Municipality may join with any other Municipality or Municipalities for the purpose of exercising any of its powers:

AND WHEREAS, the Corporation of the Township of Langley has, by by-law No. 984, established a Recreation Commission:

AND WHEREAS, the Corporation of the City of Langley has, by by-law No. 467, established a Recreation Commission:

AND WHEREAS, the Council of the Corporation of the City of Langley has agreed with the Council of the Corporation of the Township of Langley to combine the Recreation Commissions of the respective Municipalities as a Joint Recreation Commission:

NOW THEREFORE, the Council of the Corporation of the City of Langley in open meeting assembled enacts as follows:

- (1) The Council of the Corporation of the City of Langley is hereby authorized and empowered to execute an agreement with the Council of the Corporation of the Township of Langley in the form of agreement attached hereto as Schedule "A".
- (2) On the execution of the agreement referred to above the Recreation Commissions of the respective Corporations of Langley shall be united.
- (3) The united Recreation Commission shall be known as "The Langley Joint Recreation Commission" hereinafter referred to as the "Commission".
- (4) The constitution of the Commission and its powers and duties shall be in accordance with the terms of the following instruments, copies of which are attached hereto as Schedules "B" & "C".
Schedule "B" - "Langley Recreation Commission By-Law 1959 No. 984".
Schedule "C" - "Recreation Commission Establishment By-Law 1971 No. 467".
- (5) This by-law shall not come into full force and effect until it shall have received the approval of the Lieutenant-Governor-In-Council.
- (6) This by-law may be cited for all purposes as the "Langley Joint Recreation Commission By-Law 1971 No. 468".
