

- 1 Effective February 13, 2023, a person named in Column 1 of the attached Schedule is appointed to the position shown opposite the person's name in Column 2 in the office of the minister shown opposite the person's name in Column 3.
- 2 A person appointed to a position under section 1 is to be paid in accordance with the classification band in the British Columbia Management Classification and Compensation Framework administered by the Public Service Agency shown opposite the person's name in Column 4 of the attached Schedule.
- 3 Terms and conditions of employment equivalent to those established for category B appointees in the "Terms and Conditions for Excluded Employees and Appointees" administered by the Public Service Agency apply to a person appointed under section 1.
- 4 If a person appointed to a position under section 1 of this order held a position by appointment under section 15 of the *Public Service Act* immediately before the making of the appointment under section 1, that earlier appointment is rescinded.
