

- 1** *Section 18 (3) (d) of the Groundwater Protection Regulation, B.C. Reg. 39/2016, is amended by striking out “the person responsible drills the water supply well in accordance with” and substituting “the person responsible drills the water supply well, or permanent dewatering well, in accordance with”.*
- 2** *Section 36 (2) (b) is amended by striking out “comply with subsection (3)” and substituting “comply with subsections (3), (4), (5) and (6)”.*
- 3** *Section 1 of Schedule 1 is amended*

 - (a) in paragraph (a) (i) by striking out “and mailing address” and substituting “, mailing address, telephone number and, if available, the email address”, and*
 - (b) in paragraph (d) (i) by adding “, including business name, if any, address, telephone number and, if available, email address and fax number” after “professional”.*
- 4** *Section 1 of Schedule 3 is amended*

 - (a) in paragraph (a) (i) by striking out “and mailing address” and substituting “, mailing address, telephone number and, if available, the email address”, and*
 - (b) by repealing paragraph (j) and substituting the following:*

 - (j) the following information relating to the person responsible for drilling or altering the well:

 - (i) if applicable, the registration number of

 - (A) the person responsible for drilling or altering the well, and
 - (B) the person who drilled or altered the well, if different from the person referred to in clause (A);
 - (ii) the name and business contact information, including business name, if any, address, telephone number and, if available, email address and fax number of

 - (A) the person responsible for drilling or altering the well, and
 - (B) the person who drilled or altered the well, if different from the person referred to in clause (A), .
- 5** *Section 1 of Schedule 4 is amended*

 - (a) in paragraph (a) (i) by striking out “and mailing address” and substituting “, mailing address, telephone number and, if available, the email address”, and*
 - (b) by repealing paragraph (c) and substituting the following:*

 - (c) the following information relating to the person responsible for decommissioning the well:

 - (i) if applicable, the registration number of

 - (A) the person responsible for decommissioning the well, and

- (B) the person who decommissioned the well, if different from the person referred to in clause (A);
- (ii) the name and business contact information, including business name, if any, address, telephone number and, if available, email address and fax number of
 - (A) the person responsible for decommissioning the well, and
 - (B) the person who decommissioned the well, if different from the person referred to in clause (A), .
