- (a) the Professional Governance General Regulation, B.C. Reg. 107/2019, is amended as set out in the attached Appendix 1,
- (b) the Agrologists Regulation, B.C. Reg. 10/2021, is amended as set out in the attached Appendix 2, and
- (c) the Applied Biologists Regulation, B.C. Reg. 13/2021, is amended as set out in the attached Appendix 3.

APPENDIX 1

- 1 *Section 1.6 (3) of the Professional Governance General Regulation, B.C. Reg. 107/2019, is amended by adding “of the Act” after “section 82 (2)”.*
- 2 *Section 1.7 (1) (b) is amended by striking out “be suffering from” and substituting “have”.*
- 3 *Section 8 (1) is amended by adding the following paragraphs:*
 - (e) information relating to the results of an investigation or an audit under section 10 of the Act;
 - (f) information relating to any administrative penalties imposed under section 99 of the Act;
 - (g) information relating to any enforcement actions, other than the imposition of an administrative penalty, taken under Part 8 of the Act as a result of an inspection under section 9.1 [inspections by superintendent] of the Act.
- 4 *Section 9 is repealed.*

APPENDIX 2

- 1 *Section 1 (1) of the Agrologists Regulation, B.C. Reg. 10/2021, is amended by adding the following definition:*

“limited licence agrologist” means an individual who is registered with the regulatory body as a limited license agrologist in accordance with the bylaws of the regulatory body; .
- 2 *Section 3 is amended by adding the following paragraph:*
 - (e) “limited licence agrologist”.
- 3 *Section 4 (1) is amended by adding “in section 1 (1) of this regulation” before “is a reserved practice” and “or limited licence agrologist” after “an agrologist”.*

APPENDIX 3

- 1 *Section 1 (1) of the Applied Biologists Regulation, B.C. Reg. 13/2021, is amended by adding the following definition:*

“applied biology limited licensee” means an individual who is registered with the regulatory body as an applied biology limited licensee in accordance with the bylaws of the regulatory body; .
- 2 *Section 3 is amended by adding the following paragraph:*
 - (g) “applied biology limited licensee”.

- 3 *Section 4 is amended by striking out* “a registered professional biologist or registered biology technologist” *and substituting* “a professional biologist, registered biology technologist or applied biology limited licensee”.
