

- 1** *Section 29 (3) (a) of the Excluded Employees (Legal Proceedings) Indemnity Regulation, B.C. Reg. 62/2012, is amended by striking out “section 33.1 (1) (b)” and substituting “section 33 (2) (c)”.*

SCHEDULE 2

- 1** *Section 3.3 (1) (d) of the Family Law Act Regulation, B.C. Reg. 347/2012, is amended by striking out “section 33.1 (1) (s)” and substituting “section 33 (3) (h)”.*

SCHEDULE 3

- 1** *Sections 3 (1), 4 (2) and 5 (2) of the Freedom of Information and Protection of Privacy Regulation, B.C. Reg. 155/2012, are amended*

(a) by repealing paragraph (f), and

(b) in paragraph (h) by striking out “section 33.1 (1) (b)” and substituting “section 33 (2) (c)”.

- 2** *Section 6 (b) is amended by striking out “an aboriginal people” and substituting “an Indigenous people”.*

- 3** *Section 8 is amended by striking out “section 33.2 (f)” and substituting “section 33 (2) (s)”.*

- 4** *Section 11 is amended*

(a) in subsection (1) by striking out “section 26 (d), 30.1 (a), 32 (b) and 33.1 (1) (b)” and substituting “sections 26 (d), 32 (b) and 33 (2) (c)”;

(b) by repealing subsection (2) (b),

(c) in subsection (2) (d) by striking out “section 33.1 (1) (b)” and substituting “section 33 (2) (c)”, and

(d) in subsection (3) by adding “, as that section read on June 25, 2012,” after “of the Act”.

- 5** *Section 15 and Schedule 3 are repealed.*
